## MRS. HORTON DIES AT ADVANCED AGE

Widow of Late Dexter Horton, 87 Years Old, Succumbs to Stroke of Paralysis, Late Yesterday.

Following an illness extending over a period of two years, Mrs. Arabella C. Horton, widow of the late Dexter Horton, died late yesterday at the family home, 627 Fourteenth Avenue North. The direct cause of death was a paralytic stroke which she suffered three days previously, similar to one which made her an invalid two years ago. She was 87 years old.

Prior to the death of her husband ten years ago, Mrs. Horton enjoyed and extremely wide acquaintance in Seattle, retaining many of her friends even after she went into seclusion after Mr. Horton's demise. As a member of the Ladies' Relief Society, she distributed much charity, although all of her gifts were unostentatious. Until a short time before her death she enjoyed the full possession of her faculties and spent much time in reading.

The deceased was born on March 17, 1827, in Odessa, N. Y. In 1881 she married Mr. Horton and came to Seattle, living for a time on Third Avenue and Seneca Street and later moving to the home on Fourteenth Avenue North.

Mrs. Horton was survived by two stepchildren, Mrs. W. G. Jones and Miss Caroline E. Horton, both of Seattle. Bonney-Watson Company is in charge of the remains.

Funeral services will be held Wednesday afternoon at 2 o'clock from the family residence, Rev. J. M. Gill officiating. Mrs. Horton will be buried in the family lot at Lake View cemetery.

## MAYOR RAISES OBJECTION
